### Auction Terms and Conditions for the sale of firearms

By registering and placing bids online, all buyers agree to the following Terms & Conditions of Sale. By checking the box to register and place your first bid, you acknowledge that you have read, understood, and agree to these terms.

Effective September 13, 2023: Prior to transferring any firearm, rifle, shotgun, or ammunition, a background check through the New York State (NYS) system is mandatory. This includes the following charges for NYS buyers:

\$9.00 per firearm transaction

\$2.50 per ammunition transaction

\* If you are an out-of-state buyer who is picking up a firearm or ammunition you MUST have CASH for the NYS NICS fees

Payment of Background Check Fees:

These charges will appear as a line item on your invoice and will be automatically charged when we process your payment at the close of the auction (NYS buyers only).

Out-of-state buyers picking up a firearm or ammunition must bring CASH to cover NYS NICS fees.

If you are an NYS resident requesting shipping and have already been charged the line item fee, this will be deducted from your shipping/handling charges for the auction.

Failure to pass the background check will result in forfeiture of the item, with no refunds. You will have the option to consign the item to a future auction.

Bidders/buyers should be aware that the firearm will not be transferred to them until the NICS check comes back with a "proceed" response. Auctions International, Inc. is not liable for any delays in NICS approval

### Firearm Sales Compliance:

New York State law requires a National Instant Criminal Background Check (NICS) prior to any firearm, rifle, or shotgun sale or transfer. It is illegal to transfer a firearm at an auction without first conducting this background check.

Muzzle-loading rifles and shotguns also require a state background check under NYS law. These transactions will be processed through the NYS NICS system, and this will be noted in the lot description where applicable.

### Final Sale Terms:

All sales are final. No returns or chargebacks will be accepted under any circumstances.

By placing a bid, you agree to all terms and conditions and accept full responsibility for completing the transaction, including arranging pickup or shipping.

### Pickup & Appointments:

Firearms and ammunition: Pickup is by appointment only. Please respect the scheduled dates and times. Shipping available upon request. Buyer will need to provide a pre-paid shipping label. Firearms will only be shipped to FFL dealers.

Local delivery within 25 miles of our office to your preferred FFL available, for a fee.

Accessories: No appointment is required for pickup.

### Legal Compliance:

Buyers are responsible for understanding and complying with state and federal laws governing the purchase of firearms and ammunition. Any item you win at auction that you are legally unable to own or transfer remains your responsibility. If you fail the background check or are restricted by law, you may consign the item to a future auction for a 25% commission fee.

**Semi-Automatic Rifles:** In NYS, a permit is required to purchase a semi-automatic rifle. Please contact your local county office for details. For out-of-state buyers, semi-automatic rifles can be shipped to an FFL in your state but cannot be picked up in NY without a permit. If you are a NYS Buyer and purchase an item you cannot have, you must pay for the item and it can be re-sold in a future auction, you WILL NOT get a refund.

**"As Is, Where Is" Policy:**

All items are sold "As Is, Where Is" with no warranties or guarantees of any kind, expressed or implied. This includes, but is not limited to, warranties of merchantability or fitness for a specific purpose.

Descriptions are provided as a guide and are not guaranteed for accuracy regarding condition, authenticity, size, or provenance. Buyers are encouraged to inspect items prior to placing bids.

**Condition Reports:** Where applicable, obvious flaws are noted in the condition description. Firearms listed as "As New" may not necessarily be brand new. If a firearm is brand new and unfired, it will be explicitly stated.

**Buyer's Premium:**

A Buyer's Premium will be applied to all purchases and will be reflected in auction advertisements and catalogs. The Buyer's Premium is a percentage of the final purchase price and is payable by the buyer as part of the total price.

**Additional Terms:**

Items may be sold individually or by lot. In the case of quantity items, the bid price will be multiplied by the number of items in the lot. Example: A bid of \$12.50 x 4 equals a total bid of \$50.00.

No chargebacks will be permitted. All sales are final upon the close of the auction.
